The Producer insignia is the **S.P.A.** (in capitols) acronym that appears following the names of the producer/s lodging the **Levy Request for Information Form (RFI)** for members or the **Notice of Producer Credit Form** for non-members for their feature, documentary or long form television (drama, narrative comedy or children's) production **completed after 1 January 2014** with Screen Producers Australia.

The **S.P.A.** insignia is an accreditation mark only and does not necessarily indicate membership of Screen Producers Australia, however it does signify that the credited producer/s performed a majority of the producing duties on the film as outlined in the Producer Credit Criteria found at www.screenproducersaustralia.org.au/producer-accreditation-system.

Following receipt of this form, Screen Producers Australia staff will offer the verified producers on this production the use of the **S.P.A.** acronym. Use of the **S.P.A.** acronym is entirely optional. All information is held in the strictest confidence and is for internal use only.

IMPORTANT NOTICE: Lodgment of this form is for accreditation purposes only and **does not** entitle non-member producers and/or businesses and their employees to utilise Screen Producers Australia agreements and template contracts under any circumstances. These documents are for exclusive use on member productions and unauthorised use by non-members is in breach of Screen Producers Australia intellectual property rights.

The levy is calculated at 0.25% of the total production budget, excluding indirect costs. This amounts to \$250 for every \$100,000 in eligible expenditure. The maximum total levies payable in the 2015/16 financial year per member business is \$75,000+GST. In the case of official co-productions, the levy is payable only on the Australian component of the budget. The levy is considered a Qualifying Australian Production Expenditure (QAPE) for the purpose of the Producer Offset. Levies are payable on the first day of principal photography.
